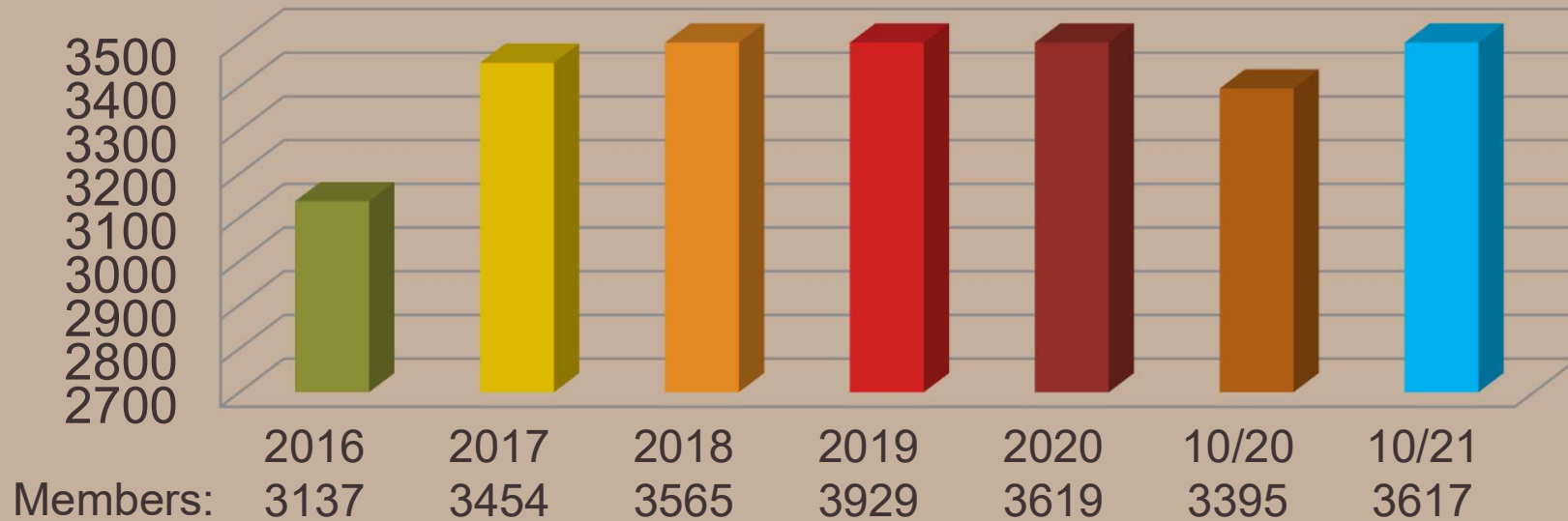

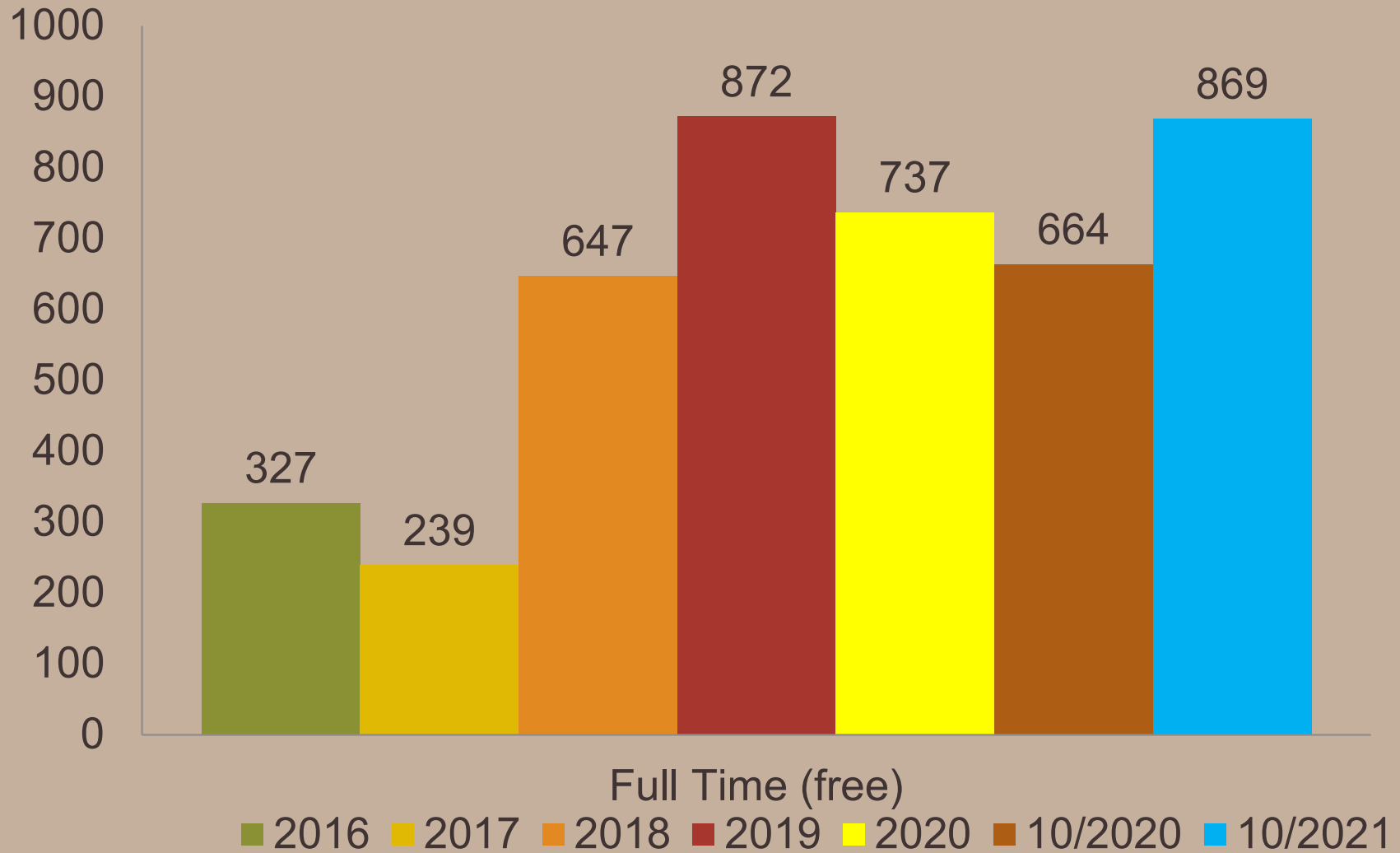

# Membership Totals

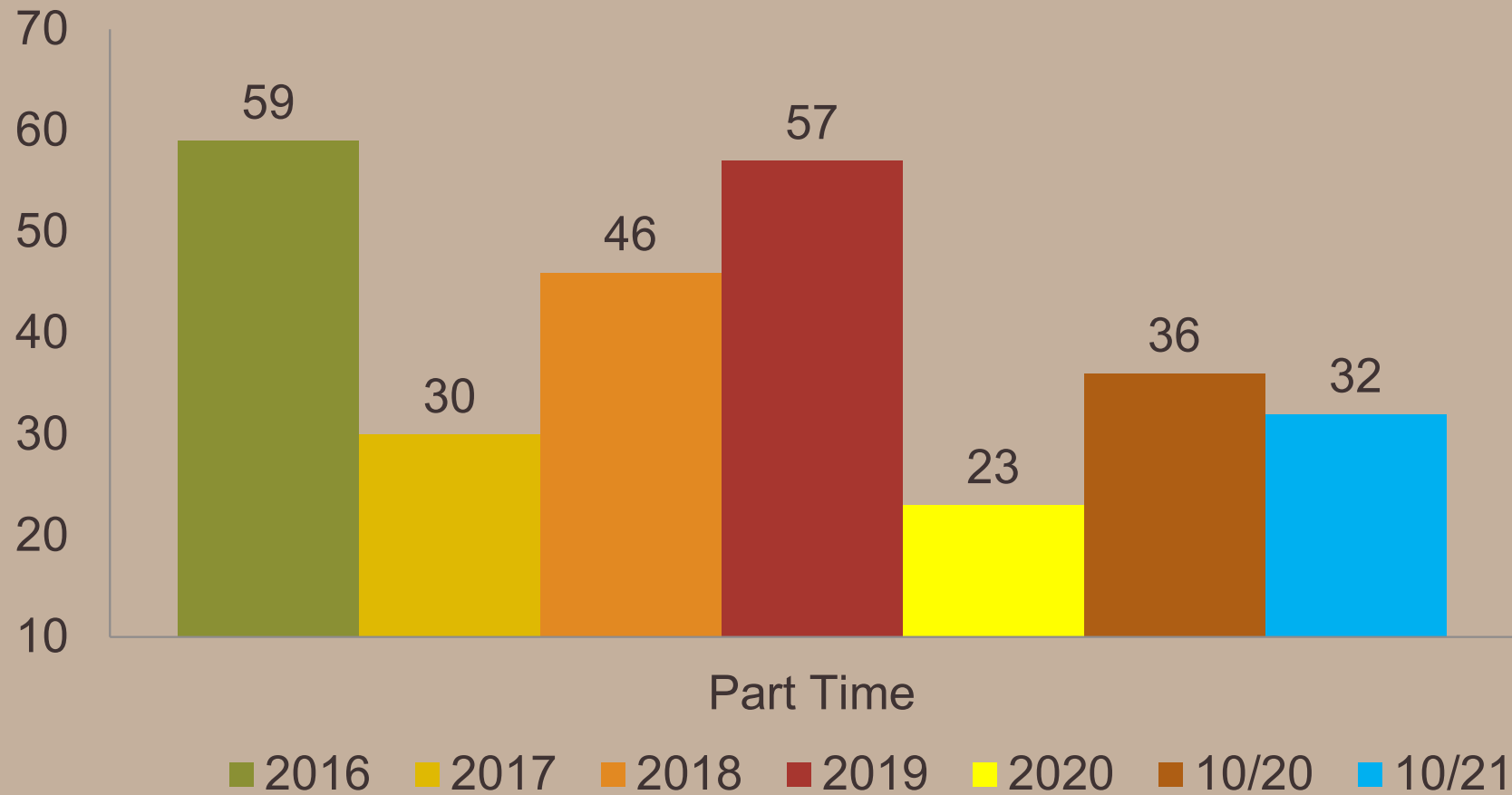

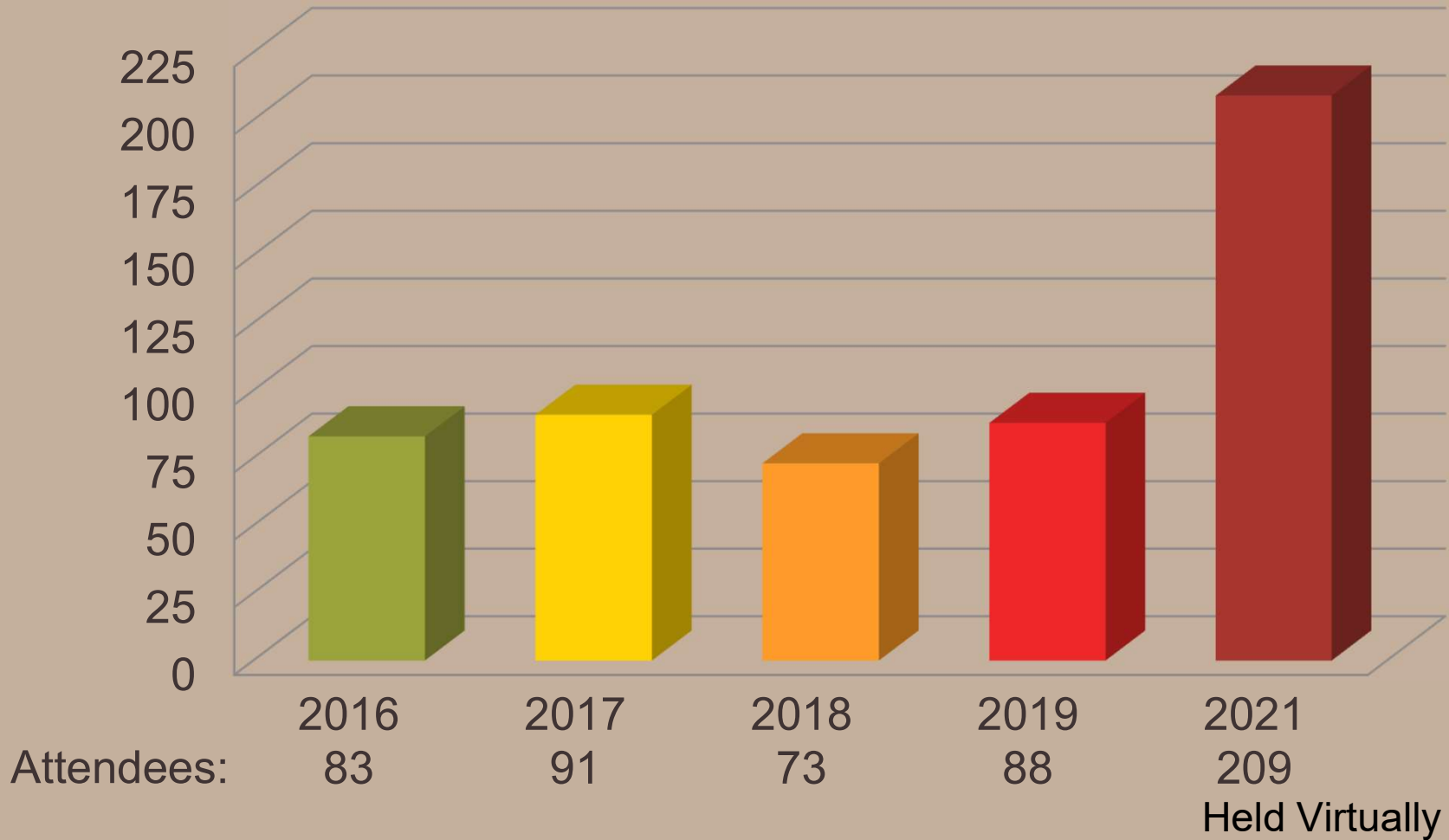

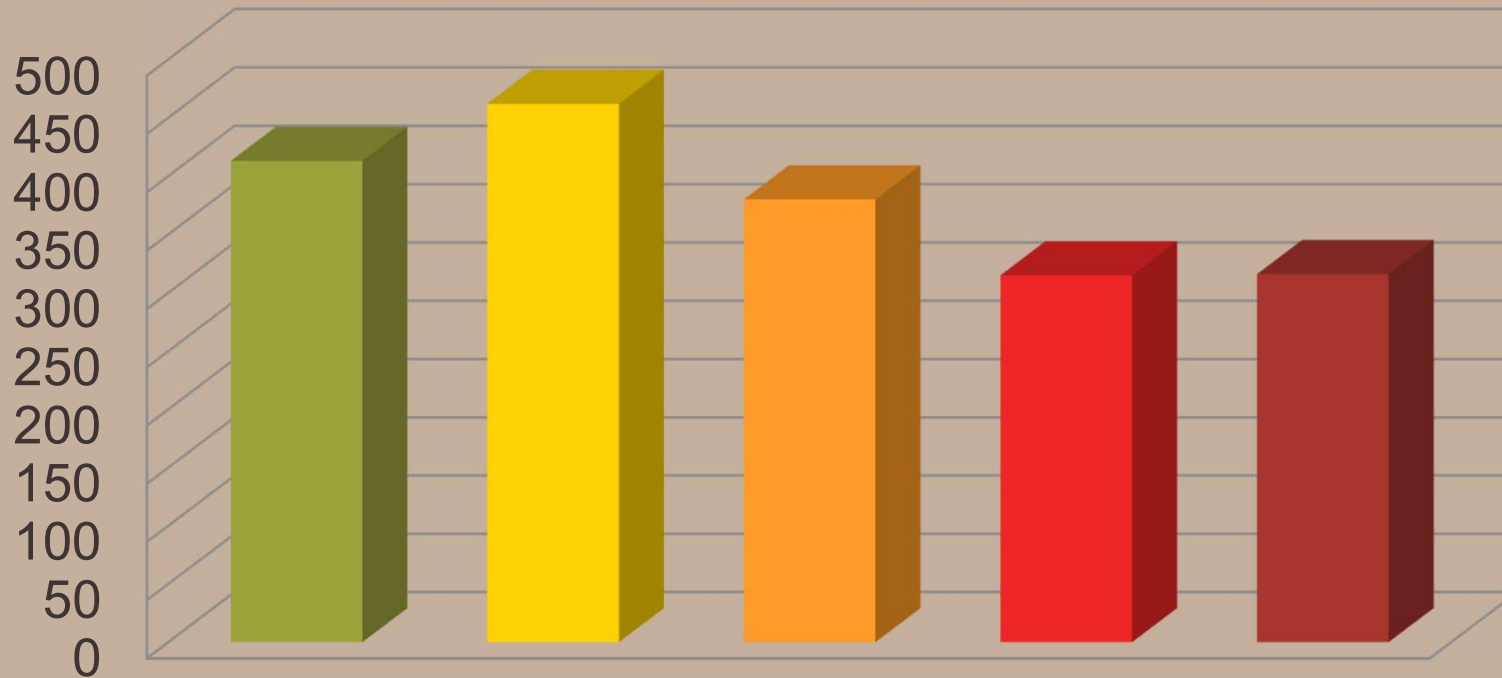

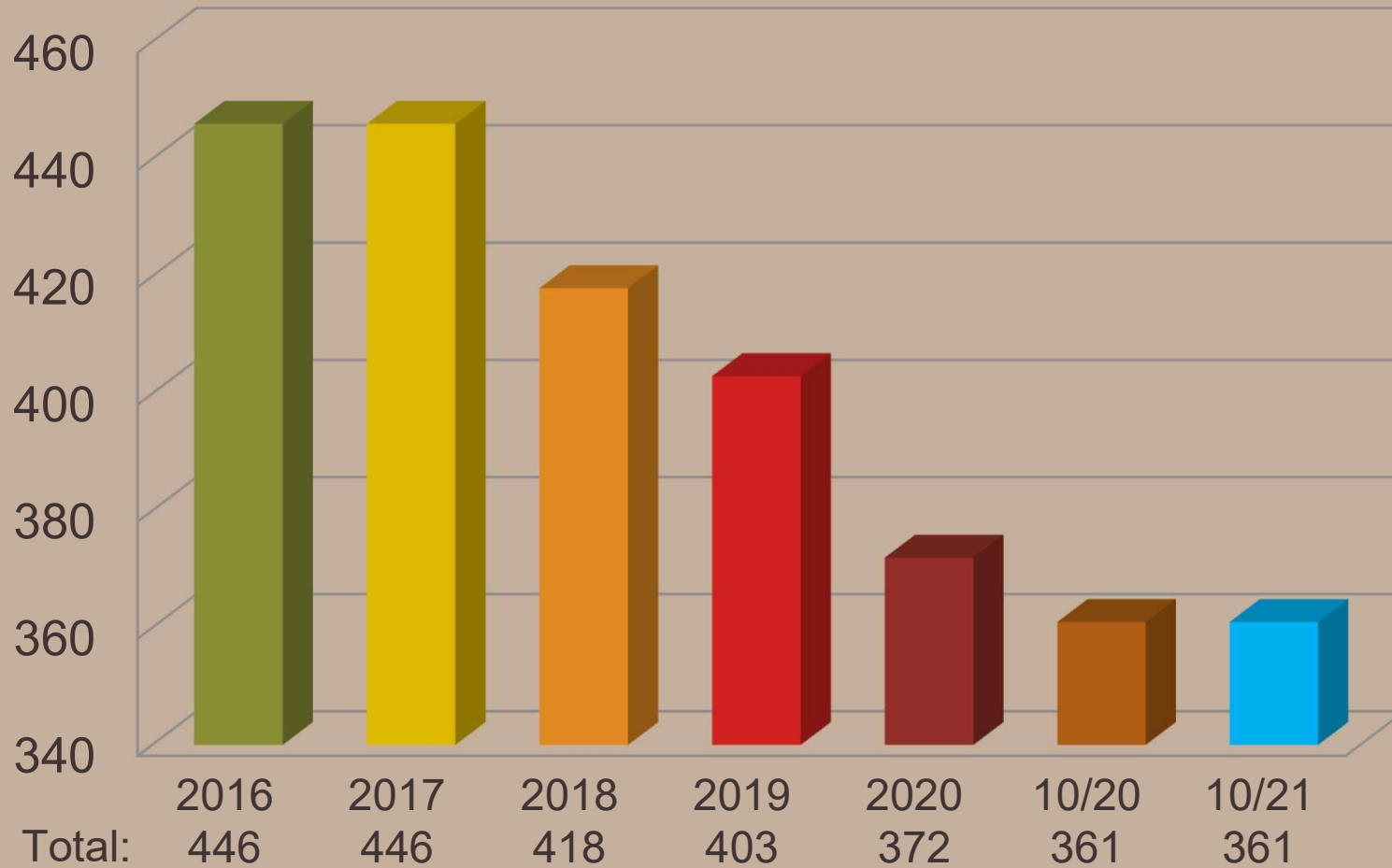
# 2021 Certification Exams

  - 9 CCT exams passed in 2021

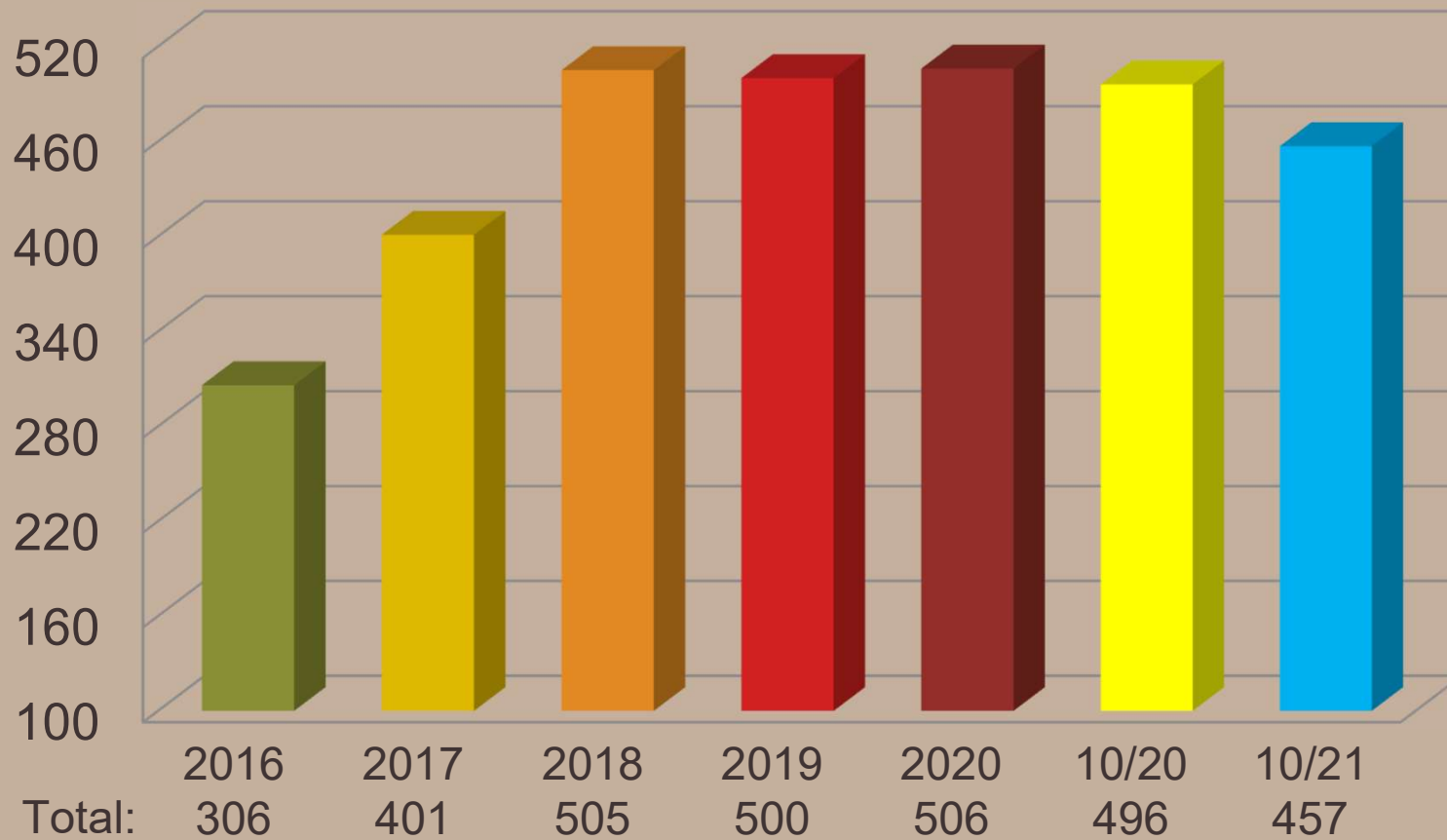

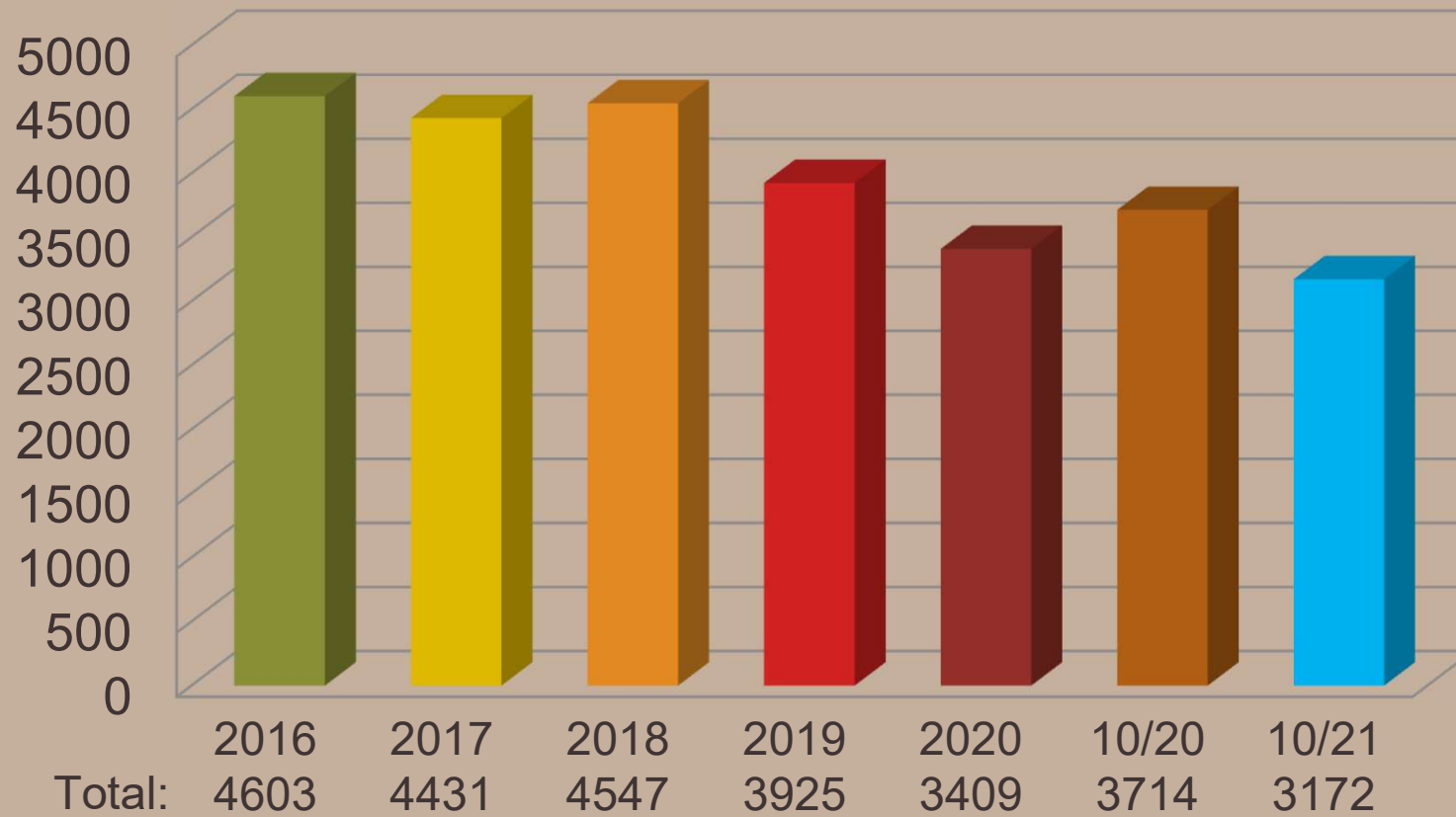
